- **Budgeting & Financial Literacy** – Rotary Scout Hut, Salida – Thursday, October 23rd from 2:30 – 4:30 p.m. This dynamic workshop will examine the financial tools, principals, and structures that undergird nonprofit organizations. Participants will engage with exercises meant to connect their missions with their budgets. In addition, participants will walk away with an understanding of how financial statements are built, and how to read them in order to learn about an organization’s financial health. This workshop is sponsored by Collegiate Peaks Bank. This session is designed for board members, staff, and Chaffee residents alike.

- **Board Member & Candidate Training** – Are you currently serving on a nonprofit board? Or have you thought about joining a board? This training is designed to provide a foundational understanding of nonprofit organizations, how they function and what separates them from for-profit businesses. Participants will learn about the role of a board of directors in governing and guiding nonprofits, as well as develop an understanding for the different types of boards.
