Successful Launch to Peak Health Alliance Work in Chaffee County

Chaffee County, CO – The Chaffee County Community Foundation (CCCF) is excited to share that its January 8th public launch of work with Peak Health Alliance (PHA) to reduce health insurance costs and increase transparency was well attended and well received. The day began with a CCCF-hosted employer forum at the Rotary Scout Hut in Salida at which PHA presented their model for lowering health insurance premiums for Chaffee County residents as soon as 2021. PHA CEO Tamara Pogue said "At Peak, we believe that that communities need to feel empowered to address the unique healthcare challenges facing them. Because each county brings with it different circumstances, a top-down, one-size-fits-all approach simply doesn't work in a purchasing alliance. Peak has succeeded because our model emphasizes the local control and leadership necessary to help citizens feel part of a locally-driven solution."

Following this forum, Peak Health Alliance met with the Chaffee County steering committee, convened by CCCF, who will be responsible for the community engagement, and decision making about how to negotiate with local providers, and ultimately, if and which carriers to use for Peak health plans in 2021 in the county. PHA presented Chaffee County claims and Medicare report data to the steering committee, which selected two primary goals that will drive their work here in the county. First, the committee wants to increase the transparency and sense of ownership and voice of community members and employers with the health care providers and carriers. Second, the committee aims to be able to negotiate lower health insurance premiums to be available to Chaffee County residents for the 2021 coverage year. This steering committee is comprised of local leaders including County Commissioner Rusty Granzella, and Director of Public Health Andrea Carlstrom.

The day ended with a meeting between the Heart of the Rockies Regional Medical Center (HRRMC), Peak Health Alliance, and the steering committee. The meeting was positive and HRRMC is continuing their role in the community as an innovator and partner by agreeing to work with PHA and the steering committee to pursue options which could be mutually beneficial.

The timeline moving forward with this work is extremely tight, being driven by the state's Division of Insurance's deadline of May 31st for insurance carriers to submit their 2021 rate and plan proposals. CCCF and the steering committee will be working to engage community members, employers (both small group and self-funded), providers, and other stakeholders over the next 6 – 8 weeks. The goal of this work is to get a significant number of Letters of Intent demonstrating interest from individuals and employers of all sizes in potential Peak health plans.
